11.	<ul> <li>This Project shall consist of:</li> <li>The contractor is a company or corporation with expertise in the business of providing general cleaning and maintenance and repair service for all the equipment, machine and electrical system of the clients. In providing above mentioned the services, the Contractor shall provide service in a safe diligent and skilful manner in accordance with the generally accepted terms and conditions.</li> <li>The contractor shall undertake the following:</li> </ul>

For cleaning and maintaining the air-conditioning system of the Embassy, the client shall pay the agreed quarterly service fee of Two Hundred Fifty US Dollars (US\$250.00)to the contractor. The service fee for maintaining the lighting system, water and sewage system, and repairs of generator shall be paid on a per hours basis. charges are itemized as follows: \$12.50/per hour for Repair of AC and Refuel \$35.00/per unit of AC; \$60.00 cleaning/repair of water tank and sewage system; and \$200++ for changing the oil of the generator every 250hrs of use and Other services shall be paid accordingly and as agreed upon.
