#### PHILIPPINE ENVOY PRESENTS CREDENTIALS TO TIMOR-LESTE PRESIDENT

Philippine Ambassador to Timor-Leste Evelyn D. Austria-Garcia presented her credentials to H.E. President Taur Matan Ruak on 30 September 2015.

In her brief remarks during the formal ceremony, Ambassador Austria-Garcia extended the warm greetings of Philippine President Benigno S. Aquino III to President Ruak and the Timorese people. She also conveyed President Aquino's best wishes for the continued good health of his Timorese counterpart and the prosperity of the Timorese nation.

In a subsequent private meeting with President Ruak, Ambassador Austria-Garcia said that she is committed to work closely with the Timor-Leste Government to further strengthen the bilateral relations between the Philippines and Timor-Leste.

Citing the two countries' many commonalities, such as their shared Catholic heritage and core values, the Ambassador expressed optimism that the already strong bilateral ties between the Philippines and Timor-Leste will continue to grow and flourish.

For his part, President Ruak thanked the Philippine Government and the Filipino people for their generous support and assistance to the nation-building efforts of Timor-Leste, particularly in the area of human resource

development and capacity-building. He stressed that "the Philippines has done a lot for Timor-Leste since 1999." He assured Ambassador Austria-Garcia of the Timor-Leste Government's assistance in fulfilling her mandate.

During the meeting, both officials agreed that the two countries should continue their ongoing educational cooperation, including in areas such as tourism and cultural development, which President Ruak identified as needing human resource development and institutional building.

The ceremony for the presentation of credentials ended with Ambassador Austria-Garcia inspecting the Honor Guards.

The Ambassador was accompanied at the ceremony by her husband, Mr. Rico M. Garcia, Third Secretary and Vice Consul Maurice A. Tiempo, Defense and Armed Forces Attaché (DAFA) Col. Emilio T. Hulipas, Attaché and Administrative Officer Reynold D. Banda, and Administrative Assistant to the DAFA MSg Glen A. Paloyo.







## History of the Embassy

As an expression of the Philippine Government's recognition of Asia's newest democracy, President Gloria Macapagal-Arroyo designated Secretary of Socio-Economic Planning Dante B. Canlas as her special envoy to the Independence Day celebration of Timor-Leste on 20 May 2002. During this visit, Secretary Canlas and Dr. José Ramos-Horta, Senior Minister and Minister of Foreign Affairs and Cooperation of Timor-Leste, signed a Joint Communiqué establishing diplomatic relations between the two countries.

Timor-Leste's Prime Minister Mari Alkatiri visited the Philippines to sign a country agreement with the Asian Development Bank on 15-18 August 2002. On 16 August 2002, a bilateral meeting was arranged between him and then Foreign Affairs Secretary Blas F. Ople. During the meeting, Prime Minister Alkatiri conveyed that the Timor-Leste Government was amenable to the request of the Philippine Government to concurrently accredit the Philippine Embassy in Jakarta to Dili.

On 08 May 2003, the Government of the Democratic Republic of Timor-Leste granted agrément to the nomination of Ambassador Rafael E. Seguis as the Philippine Government's non-resident Ambassador Extraordinary and Plenipotentiary to Timor-Leste with residence in Jakarta. Consequently, Ambassador Seguis presented his credentials to President Kay Rala Xanana Gusmão at the Palace of the Ashes on 04 August 2003.

Preparation for the opening of the resident Embassy was undertaken by First Secretary Edsel P. Barba upon his arrival in Dili in May 2004. On 17 May 2004, Ambassador Farita Aguilucho-Ong presented her credentials to President Gusmão as the first resident Philippine Ambassador to Timor-Leste. She was followed by Ambassador Leoncio R. Cardenas who assumed the post on 11 February 2008.

Ms. María Aileen H. Bugarín served as Ambassador from July 2009 to July 2015.

The Embassy is currently headed by Ambassador Evelyn D. Austria-Garcia.

## PHL FOREIGN AFFAIRS SECRETARY DEL ROSARIO AND TIMOR-LESTE FOREIGN MINISTER COÊLHO DISCUSS DEEPENING OF PHILIPPINES-TIMOR-LESTE RELATIONS\*



Secretary Albert F. del Rosario met with his counterpart, His Excellency Hernani Coelho Da Silva, Minister of Foreign Affairs and Cooperation of the Democratic Republic of Timor-Leste on December 17. The visit reaffirmed the strong partnership between the Philippines and Timor-Leste, which was established in May 2002.


The two Ministers discussed enhancing cooperation in the areas of defense, economic relations, education, health, and technical/capacity building, among others. They also discussed the strong people-to-people linkages between the two countries. They likewise agreed to enhance economic cooperation, and continue their efforts to deepen Philippines-Timor-Leste relations through the

Philippines-Timor-Leste Policy Consultations mechanism, the first meeting of which was held in Manila in 2014. Secretary Del Rosario affirmed that "the Policy Consultations will continue to serve as a vehicle to facilitate matters of mutual interest in the years to come."

Secretary Del Rosario encouraged as well his counterpart to continue sending Timor-Leste diplomats to the Philippines to participate in training courses offered by the Foreign Service Institute (FSI). The Secretary hoped that the training program will significantly contribute to "the professional development of the participants and forge greater people-to-people linkages between the government of the Philippines and Timor Leste."

Secretary Del Rosario reaffirmed Philippine support for Timor Leste's application to ASEAN as the 11th member state. He reiterated that "Timor Leste belongs to Southeast Asia and should be granted its rightful place within the ASEAN community."

This is the first official visit of Minister Coelho to the Philippines.

#### PHL AMBASSADOR CALLS ON TIMOR-LESTE FOREIGN MINISTER



Philippine Ambassador to Timor-Leste Evelyn D. Austria-Garcia called on Minister of Foreign Affairs and Cooperation (MFAC) of Timor-Leste Hernani F. Coêlho da Silva on 12 November 2015.

During the meeting, both officials had a fruitful discussion and exchange of views on how to further strengthen the bilateral relations between the Philippines and Timor-Leste. Ambassador Austria-Garcia took the opportunity to brief Minister Coêlho on pending bilateral initiatives in the areas of defense, health and teacher training that both sides could pursue together.

The Ambassador reaffirmed the Philippine Government's full support for Timor-Leste's accession to ASEAN. She also thanked the Timor-Leste Government for its generous support for Philippine candidatures in international organizations and bodies.

The Ambassador likewise apprised the Foreign Minister on the developments in the West Philippine Sea (WPS), particularly on the commencement of the arbitration case filed by the Philippines against China in The Hague. She underscored the

Philippines' position that the decision of the arbitration tribunal will resolve conflicting claims on the WPS.

#### Minister for Foreign Affairs and Cooperation

Mr. Hernanai Coelho, the current Minister for Foreign Affairs and Cooperation of the Democratic Republic of Timor-Leste (RTDL) was sworn into Office on February 16, 2015. Prior to this ministerial post he served as Timor-Leste's Ambassador to Australia, Republic of Korea and New Zealand. He was also the Deputy Chief of Staff for the President of the Republic from 2010 to 2012 and Chairman of the Institute of Diplomatic Studies of the Ministry of Foreign Affairs and Cooperation of Timor-Leste from 2012 to 2013, before taking up his post as Ambassador to the Republic of Korea.

Minister Coelho joined the Ministry of Foreign Affairs in 2005 as the Interim Director of Bilateral Affairs.

Mr. Coelho enjoys martials arts, travel, Ancient culture, Hiking, Tracking, Research activities and Politics which is demonstrated by his active role as a member of the Central Committee of the FRETELIN party.

He is married and has one daughter.

#### ENHANCING DEFENSE RELATIONS

Established in 2010, the Office of the Philippine Defense and Armed Forces Attaché (ODAFA) of the Philippines is mandated to strengthen defense and military cooperation between the Philippines and Timor-Leste.

In accordance with the one country team approach, the ODAFA reports to and coordinates with the Embassy on developments in Timor-Leste that may be relevant to Philippine defense and security interests.

#### DAFA HOLDS BRIEFING FOR MILITARY HOUSE

Philippine Defense and Armed Forces Attaché (DAFA) Col. Emilio T. Hulipas held a briefing for the officers and staff of the Military House of the Office of the President (OP) of Timor-Leste on 6 November 2015.

Upon the request of OP, Col. Hulipas updated the Timorese participants on the status of the defense and military cooperation between the Philippines and Timor-Leste. He also explained the roadmap drafted by the Philippine Government to pave the way for the transformation of the Philippine army into a "world-class army." The concepts discussed were meant to help the OP formulate a strategic military work plan.

Upon instructions of the Philippine Ambassador, Col. Hulipas took the opportunity to apprise the Timorese military officials on developments with regard to the Philippine position on the West Philippine Sea issue.

Col. Jose "Trix" da Costa Soares, Chief of OP's Military House, led the Timorese participants in the said briefing.



### ECONOMIC DIPLOMACY

#### 2nd REGIONAL SEARCA FELLOWS ASSOCIATION CONFERENCE OPENS IN DILI



The Philippine Embassy in Dili led by Ambassador Evelyn D. Austria-Garcia attended the opening ceremonies of the 2<sup>nd</sup> Regional SEARCA Fellows Association Conference on Food Security, Poverty Reduction and Climate Change Adaptation. The event was held at Hotel Timor in Dili from 8 to 9 October 2015.

The conference was organized by Timorese nationals who completed their graduate studies in agriculture, forestry, and related fields under the sponsorship of the Southeast Asian Regional Center for Graduate Study and Research in Agriculture (SEARCA). Some of the Timorese scholars studied in the University of the Philippines Los Baños, and are now holding key positions in \_\_\_\_\_\_

the Ministry of Agriculture and Fisheries of Timor-Leste and other local institutions.

State Minister, Coordinating Minister for Economic Affairs, and Minister of Agriculture and Fisheries Estanislau Alexio da Silva was the keynote speaker of the conference. He called for a more integrated approach in addressing agriculture and food security issues in the country.



#### DILI INSTITUTE OF TECHNOLOGY RECTOR CALLS ON PHILIPPINE AMBASSADOR

Dr. Manuel Vong, Rector of the Dili Institute of Technology (DIT), called on Philippine Ambassador to Timor-Leste Evelyn D. Austria-Garcia last November 3.

During the meeting, Dr. Vong conveyed DIT's strong interest to link up with other Philippine universities and institutes of higher learning. He also disclosed his plans to send DIT faculty members to pursue graduate studies in the Philippines.

For her part, Ambassador Austria-Garcia thanked DIT for seriously considering the Philippines as a destination for further education and training of its teaching staff. She assured Dr. Vong of the Embassy's willingness to help the school attain its capacity-building objectives.

Established in 2002, DIT is a private, non-profit and accredited institute of higher education in Timor-Leste.

As part of its continuing **e**fforts to strengthen the people-to-people linkages between the Philippines and Timor-Leste, the Philippine Embassy in Dili hosted an

"I am pleased to note that the Timorese alumni has described their stay in the Philippines as very enriching

and productive," she said.

Ambassador Austria-Garcia also encouraged the alumni "to channel back to Timor-Leste the positive outcome of their experiences in the Philippines to enhance and invigorate the political, economic and socio-cultural platforms of their country."

Education is a major pillar of the bilateral partnership between the Philippines and Timor-Leste. The two countries signed in 2008 a Memorandum of Agreement (MOA) on Academic Cooperation which has enabled the Philippines to help Timor-Leste in its human resource development efforts. Since 2009, the Timor-Leste Government has begun deploying scholars to pursue tertiary studies in the Philippines.





## PHILIPPINE EMBASSY COMMEMORATES BIRTH ANNIVERSARY OF PRESIDENT ELPIDIO QUIRINO

The Philippine Embassy in Dili formally unveiled a mini-exhibit depicting the illustrious life and career of the late Philippine President Elpidio R. Quirino to commemorate his 125th birth anniversary.



The event was held at the grounds of Maharlika International School (MIS) on 16 November 2015. Established in 2008, MIS has been granted provisional accreditation by the Commission on Filipinos Overseas (CFO) to operate as a Philippine School Overseas (PSO) in Timor-Leste. It currently offers primary education until Grade 9 to both Filipino and Timorese children.

In attendance were 180 students and faculty members of the MIS. Also present were National Parliament Vice President Aderito Hugo da Costa and other senior ranking Timorese officials who have children studying in MIS.

A video presentation of the life and legacy of President Quirino was featured immediately after the ceremonial opening of the mini-exhibit. Selected MIS students also performed Igorot and Tagala dances.

In her remarks, Ambassador Evelyn D. Austria-Garcia highlighted the sacrifices that the late President Quirino made for the good of the Philippines and for the promotion of global peace.

Ambassador Austria-Garcia particularly recalled the tragic demise of Quirino's wife and two children during the Japanese occupation. Despite the atrocity experienced by his family under the hands of the Japanese soldiers, President Quirino granted amnesty to the Japanese prisoners of war so that peace may prosper after the war and in the world.

"Let us be inspired by the sense of nationalism and foresight of President Qurino and other great Filipinos heroes and leaders," the Ambassador told the students.

The program ended with the traditional Filipino salo-salo of puto, kutsinta and other native delicacies.

President Quirino served as the sixth President of the Republic of the Philippines. He finished the remaining term of Manuel Roxas when the latter died in office in 1948. Quirino was then elected and served as President from 30 December 1949 to 30 December 1953.

## FILIPINO BOXER PARTICIPATES IN XANANA GOLDEN BELT 2015



The Philippine Embassy in Dili reported that a Filipino boxer participated in the 2015 Xanana Gusmão Golden Belt held at the GMT Stadium in Dili, Timor-Leste last October 10.

Mr. Roldan Aldea, a 21-year old native of Kabankalan City, Negros Occidental, competed in the super featherweight division.

Named after one of Timor-Leste's founding fathers, the Xanana Gusmão Golden Belt is an annual boxing competition organized by the Secretariat of State for Youth and Sports of Timor-Leste. The activity is part of the ongoing efforts of the Timor-Leste Government to develop its youth through sports.

Reflecting on the event, Philippine Ambassador to Timor-Leste Evelyn D. Austria-Garcia said, "Apart from their common Catholic heritage, the Filipino and Timorese people both share the love and passion for boxing. I am happy to note that a Filipino boxer participated in a boxing event that was well received by Timorese boxing fans and enthusiasts."

The Embassy's Attaché and Administrative Officer, Mr. Reynold D. Banda, was at the event to witness Mr. Aldea's boxing match.

#### FILIPINOS TRIUMPH IN MOUNTAIN BIKE CHALLENGE


The TLIMBC is also the fourth and final leg of the 2015 ASEAN Mountain Bike Cup.

Jun Duron, who hails from Talisay, Cebu, was declared second placer for the entire series. He earlier bagged a silver medal for the Master A category of the men's cross country olympic (XCO) race.

Meanwhile, 19-year old Ariana Thea Patrice Dormitorio settled for the silver medal in the Elite category of the women's XCO race. She was eventually crowned as the overall champion of the series after adding up all the results of the other legs.

#### PHILIPPINE AMBASSADOR MEETS WITH THE FILIPINO COMMUNITY IN TIMOR-LESTE



Hours after presenting her credentials, Philippine Ambassador to Timor-Leste Evelyn D. Austria-Garcia met and interacted with community leaders and other members of the Filipino community in Dili at the Philippine Embassy grounds last September 30.

In her remarks, Ambassador Austria-Garcia congratulated and commended the officers and members of AFET for their hard work and perseverance in holding the four-month weekend event. She stressed that the Embassy will continue to support projects and initiatives that promote greater camaraderie and esprit de corps among the members of the growing Filipino community in Timor-Leste.

Embassy officials assisted in handing out the trophies and medals to the winners for both team and individual tournaments in basketball, volleyball, badminton and table tennis.

Ambassador Austria-Garcia also inducted the newly elected Vice President and Auditor of AFET.

In keeping with its thrust to deliver more client-oriented and efficient consular services to the Filipinos in Timor-Leste, the Embassy took the opportunity to inform the community of the new consular regulations that it has implemented since October 1. These regulations include a "no lunch break" policy and the upgrading of the Embassy's consular facilities.

#### PHILIPPINES IMPROVES COMPETITIVENESS RANKING

October 2015 - The Philippines has significantly improved its global competitiveness standing, five notches higher compared to in 2014, as it landed on the 47th spot in the 2015-2016 Global Competitiveness Report of the World Economic Forum (WEF). This was an improvement from the country's 52nd place last year. The Philippines has consistently risen in the Global Competitiveness Index, going up 28 notches since 2010 during the start of the Aquino administration.

The Philippines ranked 5th out of the 10 countries in Southeast Asia, following Singapore (#2), Malaysia (#18), Thailand (#32), and Indonesia (#37).

The Philippines is also among the Top 5 "Emerging and Developing" countries in Asia, next to Malaysia, China (#28), Thailand, and Indonesia. The Philippines is ahead of India in said category.

The Global Competitiveness Report's competitiveness ranking is based on the Global Competitiveness Index (GCI), which was introduced by the World Economic Forum in 2004. Defining competitiveness as the set of institutions, policies and factors that determine the level of productivity of a country, GCI scores are calculated by drawing together country-level data covering 12 categories, otherwise known as the "pillars of competitiveness," that together make up a comprehensive picture of a country's competitiveness.

The 12 pillars are: institutions; infrastructure; macroeconomic environment; health and primary education; higher education and training; goods market efficiency; labor market efficiency; financial market development; technological readiness; market size; business sophistication; and innovation.

#### PHILIPPINES ELECTED FOR FOURTH TERM IN UN HUMAN RIGHTS BODY

29 October 2015 – The United Nations General Assembly (UNGA) elected the Philippines for a fourth term to serve in the UN Human Rights Council, the Permanent Mission of the Philippines to the United Nations in New York reported to the Department of Foreign Affairs.

The UNGA held elections on the morning of October 28 to elect 18 members to the Human Rights Council to serve from 2016 to 2018.

"The Philippines' victory in the UN Human Rights Council, for a fourth term, is a clear and strong manifestation of the international community's recognition of the Philippines' steady progress in fulfilling international human rights obligations," Foreign Affairs Secretary Albert F. del Rosario said.

Among the 15 Member States elected, only the Philippines and the Republic of Korea were elected for a fourth term, after serving in the Council in previous years.

The Council is an inter-governmental body within the UN responsible for strengthening the promotion and protection of human rights around the globe. It addresses situations of human rights violations and makes recommendations on them.

Consisting of 47 UN Member States elected by the UNGA, the Council is based at the UN Office in Geneva, Switzerland where it discusses thematic human rights issues and situations that require its attention throughout the year.

Belgium, Burundi, Côte d'Ivoire, Ecuador, Ethiopia, Georgia, Germany, Kenya, Kyrgyzstan, Mongolia, Panama, Slovenia, Switzerland, Togo, United Arab Emirates, and Venezuela were also elected as members of the Council.

The members of the Council shall serve for a period of three years and shall not be eligible for immediate re-election after two consecutive terms.

# UNITED NATIONS AFFIRMS APPOINTMENT OF FILIPINO AUDITOR AS UN OVERSIGHT CHIEF



13 October 2015—The United Nations General Assembly today unanimously approved the appointment by UN Secretary General Ban Ki-Moon of COA Commissioner Heidi S. Mendoza as Undersecretary General of the UN's Office of Internal Oversight Services (OIOS).

Ms. Mendoza is the first Filipino ever to be appointed as Undersecretary General in the UN Secretariat.

Ambassador Lourdes O. Yparraguire, Permanent Representative of the Philippines to the UN, welcomed the appointment and thanked the regional groups of the UN for their endorsement and the Member States for their affirmation of the appointment. Under UN rules, the appointment by the Secretary General is submitted to the General Assembly for approval,

Ambassador Yparraguire said, "It is a great honor for the Philippines that a highly-qualified woman from the developing world was chosen to serve in a senior position in the United Nations." She added that Commissioner Mendoza's "qualifications and wealth of experience, coupled with her commitment to excellence and integrity, make her a wise choice for the job. Her qualifications are crucial at this juncture in the history of the UN which is celebrating its 70th anniversary, moving forward with an ambitious 2030 Agenda for Sustainable Development, and pursuing a platform of reforms in various fields of UN work."

She also stressed that "good governance, rule of law, and effective, accountable and transparent institutions within the UN itself are necessary for ensuring that the UN continues to be a credible champion in the global fight against corruption and achieves its lofty goals."

The United Stats and the Nordic countries of Denmark, Finland, Iceland, Norway and Sweden also hailed the appointment. Speaking on behalf of the United States, Ambassador Isobel Coleman, Ambassador for UN Management and Reform, said that they "look forward to working with Ms. Mendoza" and are "committed to ensuring a strong OIOS to carry out robust audits and effective investigations to ferret out waste, fraud and corruption." In a similar vein, Sweden, speaking for the Nordic countries, said they "are confident that Ms. Mendoza will lead the OIOS effectively and efficiently" and noted that "an operationally independent OIOS is key to … rebuilding the confidence among the Member States that the office can play its role in protecting the integrity of the United Nations and promoting accountability within the organization."

Earlier, Secretary of Foreign Affairs Albert F. del Rosario hailed the announcement of the UN Secretary General's intention to appoint Ms. Mendoza, saying that "the appointment of Ms. Heidi Mendoza as UN Undersecretary General of an important office that aims to be an agent of change to promote responsible, accountable, and transparent administration of UN resources, is true testament of her skills and integrity as public accountant.

Ms. Mendoza is expected to begin her term on 15 November 2015. As per UN regulations, her appointment is for a fixed term of five years without renewal. As the UN's Undersecretary General for Internal Oversight, she will be responsible over the resources and staff of the organization through internal audit, monitoring, inspection, evaluation and investigation services.
